#### Call for Expression of Interest FNF/18/05 September 6<sup>th</sup> 2018

#### 1) Background

The Friedrich Naumann Foundation for Freedom in Myanmar (FNF Myanmar) collaborates with Parami Institute to enhance analytical thinking and to increase the understanding of human rights situations in Myanmar and around the world. FNF Myanmar and Parami Institute will enroll not less than 15 Myanmar students to train them in international human rights laws and compare them to current Myanmar's context for two intensive months. At the end of the project, it is expected that the students will be able to produce analytical essays on human rights situations in Myanmar.

#### 2) Objectives

- To increase the understanding of international human rights laws
- To encourage analytical thinking about human rights laws in the context of Myanmar political, economic and social situations
- To build a bridge between international and Myanmar's perspectives on human rights situations in Myanmar

### 3) Specific Output

Ten analytical essays written by Myanmar students, analyzing human rights situations and policies in Myanmar

### 4) The major role of the training provider

To implement this project, FNF Myanmar is seeking a training provider, who can design and deliver courses related to international human rights laws, Myanmar's human rights laws and situations. The training provider is also responsible to mentor the students throughout the project period, by supporting the students through knowledge on politically related subjects, preparing their analytical essays and monitoring their progress to finish their written work.

# 5) Training Provider's Competencies

Interested candidates will have to demonstrate that they have capacities and experience indicating that they are qualified to provide the service. Candidates are expected to have:

- Advanced knowledge of international and local human rights laws, human rights situations in Myanmar and around the world
- Advanced scholarly experience conducting research.
- Proven conceptual, research and analytical skills.
- Experience working with students.

Prior Affiliation towards FNF Myanmar is an asset but not essential.

6) Timeline

It is expected that the trainer would hold a meeting with all students once a week (4 hours per meeting) at Parami Institute for two consecutive months (October and November).

# 7) Consultancy Fee – Commensurable upon experience.

The consultancy fees will be divided in three payments: 30% will be paid in the first and second installments and 40% at the end of the project.
